### SCOPE OF WORK/TERM OF REFERENCE FOR HIRING OF VEHICLES FOR APIS-PCSIR ISLAMABAD.

#### 1. SCOPE OF WORK(SOW)/TERMS OF REFERENCE (TOR):

Pakistan Council of Scientific and Industrial Research (PCSIR) was established in 1953 under Societies Act to promote the cause of Science and Technology in the country. Since 1973, it is functioning under the Act of Parliament, which was amended in 1984. Chief Executive of the Council is the Chairman who is appointed by the Federal Government.

PCSIR is in the need of vehicles on rental basis for its PSDP Project titled "Research, Development and Technology Transfer of Selected Active Pharmaceutical Ingredients (APIs) for Import Substitution (PCSIR)". In this regard tender is floated for hiring good condition vehicles (2018 or up model CAR AC 1300 CC) on as and when required and rate running basis. Contractor has to provide required type of vehicles, which will be deployed as per requirement for APIs- PCSIR Islamabad.

The contractor should never be a defaulter or blacklisted from any Government or public sector organization. Contractor must have at least 01-year experience of providing rental to Government or public sector organizations.

## 2 <u>TERMS OF REFERENCE FOR HIRING OF VEHICLES FOR THE PROJECT</u> "Research, Development and Technology Transfer of Selected Active Pharmaceutical Ingredients (APIs) for Import Substitution (PCSIR)".

- i. The contract period for hiring of vehicle shall **be for a period of One (01) year** from the date of signing of contract and will be on rate running and as on as when required basis extendable on mutual consent and agreement on same rate, terms and conditions.
- ii. PCSIR reserves the right to increase or even terminate the contact before one year as per requirement.
- iii. The contract may be terminated on 30 days' notice period during contract period, if services are no more required or the contactor/company fails to abide or violates the same or do not follow the instruction of location in-charge or take no remedial/corrective measures after receiving written notice from the location in-

- charge. Similarly, the contractor/company shall serve notice 30 days prior to withdraw vehicle(s).
- iv. The bidder shall be a registered company inside Pakistan with minimum registration period of one (01) year. Provide documents for registration.
- v. Contractor/Company must have established office(s).
- vi. Bidder to confirm that none of the Directors of bidder is blacklisted.
- vii. The Bidder shall be registered/active Tax payer having valid identity/CNIC with sound financial profile capable to provide rental vehicle as per requirement of PCSIR.
- viii. The contractor/company shall confirm that the vehicle is well maintained and are in excellent condition in all respects.
- ix. The company has to provide its own or third party hired vehicle within 20 days after issuance of Lol Otherwise Performance Bond Guarantee (PBG) will be confiscated. Rent period will be started from the date of delivery of vehicle and its acceptance by APIs-PCSIR.
- x. All type of repair, maintenance and replacement of filters, engine oil and others lubricants shall be responsibility of the contractor.
- xi. Vehicle should be in compliance with HSEQ standards and be equipped with the following essentials:
  - a. First aid kit.
  - b. Fire Extinguisher.
  - c. Serviceable spare wheel.
  - d. Seat belt on all seats for all occupants in front & back.
  - e. Tool kit including jack and wheel nut spanner (Lug wrench).
- xii. The contractor to provide vehicle's model not older than year 2018.
- xiii. Vehicle will be provided with driver by the contractor company. The driver must be literate with sound mental and Physical health and must have valid CNIC, valid driving license and security clearance from the respective police station.
- xiv. The vehicle with driver will have to perform duty round the clock including holidays/gazette holidays.
- xv. PCSIR will not provide accommodation facility to driver.
- xvi. PCSIR will not provide messing facility to the driver.
- xvii. In case of any extensive break down of vehicle(s), Contractor/company shall immediately replace the vehicle(s) with same OR up model good condition
- xviii. PCSIR may install vehicle tracking system on each vehicle and contractor shall have no objection on it.

- xix. Vehicle may be deployed throughout the country for temporary assignments under administrative control of location In-charge where required, in all terrain (i.e. hilly, desert, river catchment area, plains and cultivated areas).
- xx. The contractor/company shall ensure that the documents of vehicle (registration, road permit, tax and insurance documents / fitness certificate etc.) are complete in accordance with applicable Government Laws.
- xxi. PCSIR shall not be responsible for any sort of mishap, accident, injury, death, force majeure or any unforeseen, theft, kidnapping, destruction/loss and damage to the vehicle or driver. The contractor shall also be responsible/ pay in case of traffic challans and in any case payment of fine etc.
- xxii. Upon unsatisfactory performance, behavior or involvement in illegal or immoral practices, contractor/company will immediately replace the driver.
- xxiii. Bidder must quote fixed/firm rate in financial bid format otherwise incomplete bid shall not be entertained. Bidder must strictly follow and quote prices as per financial bid format. No clause with "if & but" having financial impacts will be entertained and in such case bid will be treated as non-responsive.
- xxiv. The rates quoted by the bidder will remain the same throughout the period of contract.
- xxv. The rates quoted by the contractor/company shall be on monthly rent basis for vehicle inclusive of lube oil, salary of driver and all applicable taxes/ levies charges except Provincial/ ICT sales Tax on services.
- xxvi. Petrol for the vehicle will be provided by PCSIR. In case fuel consumption of is higher than set/allowable mileage limit, deduction will be made according to the prevailing market fuel rates at the time of payment to the contractor.
- xxvii. Payment to the contractor shall be made on monthly basis subject to tax deduction as per Government rules, based on actual availability of vehicle during the month as verified by the by the in-charge transport under provision of the contract agreement. No advance payment will be admissible. Payment shall be made in the name of the contractor/ company through cross cheque only. No cash payment is allowed.
- xxviii. While submitting invoice(s) for payment, contractor shall submit a certificate from FBR to the effect that contractor has cleared its provincial tax liability.
- xxix. All bidders must give "Clean acceptance" of PCSIR terms and conditions and withdraw all exceptions if any to become eligible for technical evaluation.
- xxx. PCSIR reserves the right to accept or reject any/all bid(s) or annul the entire bidding process at any time prior to award of (Contract).

xxxi. An Affidavit on stamp paper must be attached with the bid by the owner of vehicle that the provided vehicle has no relation/connection to any of APIs-PCSIR Employee or their relatives.

- vii. Company profile with offices details in Islamabad/Rawalpindi.
- viii. Proof of experience with Govt/semi Govt: organization.

### SPECIAL NOTE

- i. No Advance payment will be made at the time signing/issuance of the contract.
- **ii. Financial evaluation** will be carried **out** comparing 12 Months rental charges including all expenses (i.e. complete package basis). And contract will be awarded to technically responsive and financially lowest evaluated bidder.

### 4. BID PRICE

- i) Bid price must be quoted in PKR. Otherwise the bid will be rejected.
- ii) Bid price shall be inclusive of all taxes, duties, levies, charges etc., except provincial Sales Tax (PST)/ Islamabad Capital Territory Sales Tax (ICT) on services in Pakistan
- iii) The prices quoted by the successful bidder (contractor) for required services shall remain firm and final throughout contact period. The price charged by the successful bidder

(contactor) for required services shall not vary from the prices quoted by the service company.

### 5. PAYMENT TERMS:

- a. The rates quoted by the contractor/company shall be on monthly rent basis for vehicle inclusive of lube oil, salary of driver and all applicable taxes/ levies charges except Provincial/ICT sales Tax on services.
- b. HSD/ Petrol for the vehicle will be provided by APIs-PCSIR. In case fuel consumption is higher than set/allowable mileage limit, deduction will be made according to the prevailing market fuel rates at the time of payment to the contractor.
- c. Payment to the contractor shall be made on monthly basis subject to tax deduction as per Government rules, based on actual availability of vehicle during the month as verified by the in-charge transport under provision of the contract agreement. No advance payment will be admissible. Payment shall be made in the name of the Contractor/ company through cross cheque only. No cash payment is allowed.

### 6. AMOUNT OF BID BOND:

Bid Bond /Bid Security 2% is to be attached with the Technical bid(Please follow the procedure as per EPAD(PPRA).
